# C. Update on GME Programs with News Since October Board Meeting

All GME programs in MS can be found on the <u>www.OMPW.org</u> website along with interactive links to all programs individually.

1. Mississippi Medical Education and Research Consortium Delta Family

Medicine Residency- <u>Greenville</u>- This program will have its first graduation. It will graduate 7 residents, they will have accomplished 100% ABFM board score passage and 4 of the graduates will remain to practice in Mississippi. Two will remain to become faculty at the program itself. Attached is an article written in Nov. 2014 of what could be, the title was Mississippi DELTA: MISSION POSSIBLE.

- 2. Magnolia Regional Health Center- <u>Corinth</u>- INTERNAL MEDICINE, received an increase in compliment through the Affordable Care Act's increase of 200 GME slots/year nationally for 5 years.
- 3. North Mississippi Medical Center- <u>Tupelo</u>- INTERNAL MEDICINE has plans to move to 24/24/24 program starting with the 2024 NRMP.
- 4. Meharry Medical College-AE Henry- <u>Clarksdale</u>- RTT FAMILY MEDICINE is still in the works. They have had some obstacles but plans are to continue to pursue.
- 5. Southwest MS Regional Medical Center- McComb- FAMILY MEDICINE received Initial Accreditation as a 6/6/6 FM program but elected to focus on starting training in July 2024
- 6. Boa Vida Healthcare- <u>Aberdeen</u>- FAMILY MEDICINE. I was asked on several occasions this past week about the status of this program's journey and although OMPW has not been closely involved, I have met and or communicated with their leadership from time to time so every indicator point toward them continuing to pursue an FM residency in Aberdeen. In fact, I learned at MOMA last week that a former NMMC Residency grad had been hired as Program Director.
